- E. Aim to advance racial equity and social justice aspirations



- Funders





Finding #5 Emerging Field

Democratizing Evidence is an emerging field ready to be cultivated.

- Bridgespan "Strong Field" Framework
 - Shared Identity
 - Common Standards
 - Knowledge Base
 - Leadership and Grassroots
 - Funding and Policy



Recommendations



Focus on **field building**, including coordination and brokering of existing initiatives and activities.



Establish or identify an **administrative home and leadership base** to support the growing and active — but disorganized — field.



Engage in **phased strategies** for raising awareness, supporting policies for scaling, monitoring the landscape and collecting promising practices.

Questions to Consider

For practitioners:

- How to engage with usable knowledge?
- Where and when is it helpful/falls short?
- What do you want the research and funder communities to know about the application of democratizing evidence?


For researchers:

- What opportunities/constraints you face in your own context?


Tips for Practitioners & Researchers
